I hereby acknowledge receipt of and full responsibility for the Animal described above. I agree to keep him/her in my possession and to provide all necessary water, feed, shelter, grooming, veterinary care, farrier care, and humane and loving treatment. I agree to comply fully with the following terms and conditions of guardianship:

1. Whether the Animal is kept at a commercial stable, at my home, or in some other location, I will ensure that the above needs are met as well as any special needs of this particular Animal.
2. I can not sell, give away, or lease this Animal. The Safehomer is responsible for all regular/routine farrier work and veterinarian costs for services, which includes, but not limited to vaccinations, de-worming, teeth floating and hygiene. Copies of all medical and farrier costs must be mailed to HPL within 30 days of work so that we can maintain the Animals' record book.
3. In the case of any emergency, The Horse Protection League MUST be notified immediately.
4. I agree to have The Horse Protection League monitor this Animal while it is in my care and agree that should HPL feel the situation is not in the best interest of the Animal, that the Animal will immediately be returned to The Horse Protection League.
5. The brand inspection for this Animal will remain with The Horse Protection League.
6. I accept this Animal as is and assume all risk of care for it, including the risk of injury or damage, and completely release The Horse Protection League from any claim, cause of action, or liability. I also agree to save and hold harmless The Horse Protection League, its staff, agents, and volunteers from any claim, cause of action, or demand of any sort, as a result of my care and handling of this Animal.
7. I will immediately notify The Horse Protection League of any change of address or phone number of either the Safehomer or the Animal.
8. The Safehomer will not be reimbursed for documented routine expenses for the Animal. Extraordinary expenses (surgery, unusual farrier procedures, etc.) must be approved in advanced by the HPL Board of Directors.
9. I understand when I wish to return the Animal to HPL, I must continue to house and provide for the animal until the Horse Protection League has room to take it back from me.
10. I understand that if I keep the Animal in my care and custody for two years (24 months) that I have adopted the Animal and that all responsibilities, financial and otherwise, will be mine. At that time, HPL will have the Colorado Brand Certificate for the Animal transferred to my name and that I agree to abide by The Horse Protection League's Adoption Contract which I will receive upon transfer of the Animal.
